THIRD-PARTY AFFIDAVIT/STATEMENT

FOR PERSONS IN PARENTAL RELATIONSHIP SEEKING TO ENROLL CHILDREN IN SCARSDALE PUBLIC SCHOOLS AND WHO ARE UNABLE TO PRODUCE A DEED, LEASE OR MORTGAGE STATEMENT IN THEIR OWN NAME SHOWING THAT THEY OWN OR LEASE RESIDENTIAL PROPERTY WITHIN THE SCARSDALE UNION FREE SCHOOL DISTRICT.

** N.Y. Educ. Law, §3212[1] – A person in parental relation is defined as a child’s father, or mother, by birth or adoption, his step-father or step-mother, his legally appointed guardian, or his custodian. A person shall be regarded as the custodian of another individual if he has assumed the charge and care of such individual because the parents or legally appointed guardian of such individual have died, are imprisoned, are mentally ill, or have been committed to an institution, or because, they have abandoned or deserted such individual or are living outside the state or their whereabouts are unknown, or have designated the person pursuant to title fifteen-A of article five of the general obligations law as a person in parental relation to the child.

In order to enroll in the Scarsdale Public Schools, you will be asked to provide three current documents showing residency within the Scarsdale School District boundaries.

The first two proof of residency documents may include:

- Pay stub showing your address
- Income tax form that shows your address
- Utility bill or other bill in your name
- Membership documents based on residency, such as a local library card
- Voter registration card
- Driver’s license, or permit, or non-driver ID
- State or other government issued ID
- Documents from government agencies such as social service agency or the federal Office of Refugee Resettlement

The third form of proof of residency documentation is an affidavit or statement by a third party. Please see the attached form.

Please be advised that falsification of any information provided will be construed as fraudulent and will result in the pursuit of legal action, including civil and/or criminal remedies, by the Scarsdale Union Free School District. The District also reserves the right to recover tuition from appropriate parties in the event it is ultimately determined that a student is not entitled to attend school on a tuition-free basis in accordance with Board Policy Number 5152.
